Delisting Determination, The Nasdaq Stock Market, LLC,  
May 2, 2019, Presbia PLC. The Nasdaq  
Stock Market, Inc. (the Exchange) has determined to remove  
from listing the ordinary shares of Presbia PLC  
(the Company), effective at the opening of the trading  
session on May 13, 2019. Based on review of information  
provided by the Company, Nasdaq Staff determined that the  
Company no longer qualified for listing on the Exchange  
pursuant to Listing Rules 5250(f) and 5550(b).  
The Company was notified  
of the Staffs determination on April 16, 2019. The Company  
did not appeal the Staff determination to the  
Hearings Panel, and the Staff determination to delist the  
Company became final on April 25, 2019.
